## PASSPORT AMENDMENT(S)

- To request any amendment, you must also be the registered owner of the equine.
- Include a written cover note from you explaining exactly what needs to be corrected.
- Be aware any amendment will likely impact on the food chain status of the equine, where it has not already been excluded.
- To make any change to the original registration details and passport of an equine, legislation dictates this can only be confirmed by a qualified vet. Accordingly best practice requires new vet markings be provided.
- Amendment fees are payable in addition to any other service fees.
